Quantitative Requirements: To attain a Technical Controller rating, candidates must:

1. Complete an Application for Technical Controller;
2. Attend a Technical Controller clinic; and
3. Satisfactorily complete both a written and practical test which may be administered either as part of a Record Capability site pre-survey or at a Technical Controller clinic.

Maintenance Requirements: Work two record tournaments biennially (i.e., work performed January 1, 2010 through December 31, 2011 counts for renewal for 2012) and attend one Technical Controller clinic every four (4) years. Two Class C tourn may substitute one record tourn if responsible for setup/verification. Attend a Judge Clinic may substitute for a Technical Controller clinic provide the clinic cover course setup, Video Trick, Video Jump setup and new rules which applies to TC.

Application Instructions: The following site certification tasks must be performed under the supervision of the Chief Technical Controller at three (3) record capability tournaments, **one of which must be a Regional, National or US Team Trials Tournament.** The applicable blanks must be completed and signed by the Chief Technical Controller and Chief Judge of the tournament in which the experience was completed for each event for which you are making application. All of the work must be performed during USA Water Ski-sanctioned AWSA tournaments unless otherwise noted. Signatures on outdated applications will be accepted for requirements on the current form if the old form is attached to this application. Be sure to contact the Chief Technical Controller of the record capability tournament you are planning to attend well in advance of the scheduled tournament date so that you may coordinate the time when you need to arrive prior to the tournament.

Once you have completed this application for those events you are applying for, you may take this completed application to a pre-approved Technical Controller Clinic or a Record Capability site pre-survey. You must contact your Regional Technical Committee representative regarding pre-approved clinics and testing sites. It is suggested that you keep a copy of this application for your records.

At the clinic or site pre-survey, you will be given written and practical evaluations. Upon successful completion, you will be awarded your Technical Controller's rating by the Instructor/Examiner who will in turn forward this form, along with a Clinic Registration or Official's Evaluation form, to USA Water Ski Headquarters. If you are filing for a one or two-event rating, your original application will be returned to you once your rating is approved. You should continue to complete the same application when working on other event(s).

Attention Chief Judges and Technical Controllers: Please be discriminating. AWSA cannot maintain a high standard of technical controllers' qualifications unless you assume the responsibility of refusing to approve any but exceptionally qualified applicants.
