I. SELECTION SYSTEM

A. Provide the minimum eligibility requirements for an athlete to be considered for nomination to the Team:

1. Citizenship:

Athletes must be a citizen of the United States at the 2011 ~~International Water Ski and Wakeboard Federation (IWWF) Pan Am Region Wakeboard Championships~~ Windermere Wakefest and hold a valid U.S. passport that will not expire for six months after the conclusion of the Games.

2. Minimum International Federation (IF) and/or Continental Federation (CF) (PAG only) standards for participation (if any):

Must be a current, active USA Water Ski/Wakeboard member.

2011 Pan American Games Team selection will be based on performances at the 2011 ~~IWWF Pan Am Region Wakeboard Championship~~ held Windermere Wakefest April 16-17, 2011.

- C. Provide a comprehensive, step-by-step description of the method that explains how athletes will go through the selection process to become Team nominees (including maximum Team size).

Maximum Team Size will consist of up to 1 male and 1 female rider.

2011 Pan American Games Team selection will be based on performances at the 2011 ~~IWWF Pan Am Region Wakeboard Championship~~ Windermere Wakefest held in April 16-17, 2011. The tournament will consist of 4 rounds (quarterfinals, last chance qualifier (LCQ), semifinals and finals) conducted according to USA Wakeboard Class W rules.

1. ***Seeding:*** Riders will be seeded for the quarterfinals according to the 2010 IWWF World Cup Ranking List. All riders not listed on the 2010 IWWF World Cup Ranking list will be seeded by the Pan Am Random Draw List held at registration, prior to the start of the tournament:

2. ***Quarterfinals:*** The quarterfinals will consist of heats based on the number of entries received (Example with 40 riders). Competitions will use a heat system. Number of riders in each heat is based upon the number of riders who enter the 2011 ~~IWWF Pan Am Region Wakeboard Championship~~ Windermere Wakefest.

Example of pattern of heats with 40 riders (top seed is #1; last seed is #40):

Heat #1: Seeds 8, 9, 24, 25, 40 (running order; you reverse seeds so higher seed go last)

Heat #2: Seeds 7, 10, 23, 26, 39 (running order; you reverse seeds so higher seed go last)

Heat #3: Seeds 6, 11, 22, 27, 38 (running order; you reverse seeds so higher seed go last)

Heat #4: Seeds 5, 12, 21, 28, 37 (running order; you reverse seeds so higher seed go last)

Heat #5: Seeds 4, 13, 20, 29, 36 (running order; you reverse seeds so higher seed go last)

Heat #6: Seeds 3, 14, 19, 30, 35 (running order; you reverse seeds so higher seed go last)

Heat # 7: Seeds 2, 15, 18, 31, 34 (running order; you reverse seeds so higher seed go last)

Heat # 8: Seeds 1,16, 17, 32, 33 (running order; you reverse seeds so higher seed go last)



*Top rider from each heat of the Quarterfinals will advance into the semifinals. All others will go to the LCQ round.

3. **Last Chance Qualifier (LCQ)**: Number of riders in each heat is based upon the number of riders who moved into the LCQ round from the quarterfinals. The LCQ will consist of heats (Example with 32 riders):

Heat #1: Seeds 8, 9, 24, 25 (running order; you reverse seeds so higher seed go last)

Heat #2: Seeds 7, 10, 23, 26 (running order; you reverse seeds so higher seed go last)

Heat #3: Seeds 6, 11, 22, 27 (running order; you reverse seeds so higher seed go last)

Heat #4: Seeds 5, 12, 21, 28 (running order; you reverse seeds so higher seed go last)

Heat #5: Seeds 4, 13, 20, 29 (running order; you reverse seeds so higher seed go last)

Heat #6: Seeds 3, 14, 19, 30 (running order; you reverse seeds so higher seed go last)

Heat #7: Seeds 2, 15, 18, 31 (running order; you reverse seeds so higher seed go last)

Heat #8: Seeds 1, 16, 17, 32 (running order; you reverse seeds so higher seed go last)

*Top rider from each heat of the LCQ will advance to the semifinals. More than one rider from each heat may advance if necessary in order to fill all 16 slots in the Semifinals. Should more than one rider advance, the rider(s) with the highest score from the LQC will advance until there are 16 riders in the Semifinals. This decision will be made by the Chief Judge and Scorer based on the number of heats we have in the LCQ, which is based on the number of entries into the tournament. The number of riders advancing from the LCQ will be posted prior to the start of the event.

4. **Semifinals**: The semifinals will consist of 4 heats (Example with 16 riders):

Heat #1: Seeds 4, 5, 12, 13 (running order; you reverse seeds so higher seed go last)

Heat #2: Seeds 3, 6, 11, 14 (running order; you reverse seeds so higher seed go last)

Heat #3: Seeds 2, 7, 10, 15 (running order; you reverse seeds so higher seed go last)

Heat #4: Seeds 1, 8, 9, 16 (running order; you reverse seeds so higher



seed go last)

*Top two riders in each heat of the semifinals will advance to the Final Round.

5. ***Finals:*** The finals will consist of 8 riders in one heat. Higher seed will go last. The top U.S. Men's and Women's Pro rider from the 2011 ~~IWWF Pan Am Region Wakeboard Championship~~ Windermere Wakefest will be nominated to the 2011 Pan American Games Team. The 2nd place U.S. Men's Pro rider will be named as the 1st replacement for the male rider position, and the 3rd place U.S. Men's Pro rider will be the 2nd replacement for the male rider position. The 2nd place U.S. Women's Pro rider will be named as the 1st replacement for the female rider position, and the 3rd place U.S. Women's Pro rider will be the 2nd replacement for the female rider position.

LCQ, Semifinals and Finals Seedings: are determined by the position finish in previous round. If riders have identical final positions in the previous round, refer back to the previous round. If riders still have identical positions, refer to the 2010 IWWF World Cup Ranking List or the Pan Am Random Draw. For example, if rider A and rider B both finish first in their heats in the semifinals, to determine the top seed in the finals, you refer to the quarterfinals results. If, both A and B finished first in that round, refer back to the seeding on the IWWF World Cup Ranking List or the Pan Am Random Draw List used for the quarterfinals to determine seeding.

Example of Seeding for each round:

1. Rider A and Rider B both are 1st place in their heats in the semifinals
2. Rider A is seeded 3rd in his heat in the quarterfinals and Rider B is seeded 2nd in his heat. Rider B would be the higher seed going into the Final round.
3. If rider A and B are both seeded the same in the quarterfinal round, you go back to the original seeding list (based off the 2010 IWWF World Cup Ranking List and the Pan Am Random Draw List) to break the tie.

Example with LCQ:

1. Rider A and Rider B both are 1st place in their heats in the semifinals.
2. Rider A is seeded 1st in his heat in the quarterfinals and Rider B has to compete in the LCQ, Rider A would be the higher seed going into the Final round.

III. REMOVAL OF ATHLETES

- A. Prior to acceptance of nominations by the USOC, USA-WS has jurisdiction over potential nominees.

An athlete who is to be nominated to the Team by USA-WS may be removed as a nominee for any of the following reasons, as determined by USA-WS:

- Voluntary withdrawal. Athlete must submit a written letter to the USA-WS CEO/Executive Director.
- Injury or illness as certified by an approved USA-WS physician (or medical staff). If an athlete refuses verification of his/her illness or injury by an approved USA-WS physician (or medical staff), his/her injury will be assumed to be disabling and he/she may be removed.
- Violation of the USA Water Ski's Code of Conduct (Attachment A), USA Wakeboard's U.S. Team Agreement (Attachment B) and/or USA Wakeboard's Anti-Doping Policy (Attachment C).

An athlete who is removed from the Team pursuant to this provision has the right to a hearing per the USA Water Ski Constitution and Bylaws (Article 9) or the USOC's Bylaws, Section 9.

- B. After acceptance of nominations by the USOC, the USOC has jurisdiction over the Team under the USOC Code of Conduct and Grievance Procedures. This occurs no earlier than 45 days and no later than 30 days prior to the Opening Ceremonies of the Games (unless expressly waived by the USOC).

A Team member who is accepted by the USOC is subject to the USOC Code of Conduct and Grievance Procedures.

- C. An athlete may be removed as a nominee to the Team or from the Team at any time for violation of IOC, PASO, IPC, WADA, IF, USADA and/or USOC anti-doping protocol, policies and procedures, as applicable. In such instances, the adjudication process will be managed through the United States Anti-Doping Agency.

IV. REPLACEMENT OF ATHLETES

Finals: The finals will consist of 8 riders in one heat. Higher seed will go



last. The top U.S. Men's and Women's Pro rider from the 2011 ~~IWWF Pan Am Region Wakeboard Championship~~ Windermere Wakefest will be nominated to the 2011 Pan American Games Team. The 2nd place U.S. Men's Pro rider will be named as the 1st replacement for the male rider position, and the 3rd place U.S. Men's Pro rider will be the 2nd replacement for the male rider position. The 2nd place U.S. Women's Pro rider will be named as the 1st replacement for the female rider position, and the 3rd place U.S. Women's Pro rider will be the 2nd replacement for the female rider position.
