RATING MAINTENANCE REQUIREMENTS – In order to maintain a USA Water Ski Trained Driver rating, the driver must:

- complete one of the practical driving experience options listed below each calendar year;
- successfully pass a *Motor Vehicle Record (MVR) Review* once every two (2) years; and
- successfully complete the *USA Water Ski Online Trained Boat Driver Course* **OR** attend a *USA Water Ski-sanctioned Trained Boat Driver or Sport Discipline Driver Clinic* once every four (4) years

USA Water Ski will notify you via e-mail when your MVR Review and course are due for renewal.

INSTRUCTIONS – Return completed/signed form to USA Water Ski’s Officials’ Program Coordinator via e-mail, fax or mail by **DECEMBER 1ST** each year. Be sure to retain a copy for your records.

OPTION 1 – participate as a driver in at least one (1) USA Water Ski-sanctioned GrassRoots tournament or Basic Skills clinic per calendar year. Document this experience and have it signed off below.
